JAY LANES 10, 9, 8 NO-TAP SINGLES TOURNAMENT

Tournament Rules:

1. First Game – Regulation tenpin bowling (you need to knock down all ten pins on your first ball to score a strike). Second game – knock down 9 or 10 pins with your first ball during second game only and it is scored a strike. Third game – knock down 8, 9 or 10 pins with your first ball during the third game only and it is scored a strike.
2. All entries and competition in this tournament must be in accordance with the rules and regulations of United States Bowling Congress.
3. Each entrant must be a member of USBC. Non-USBC members can enter tournament by purchasing a membership for \$22 (includes National, State and local dues).
4. Entry fees must be paid in full and accompany the entry. All information must be filled out on the entry form.
5. AVERAGES: Entrants shall use their highest USBC previous season's winter league average with 21 games or more. If no winter league average, entrant may use highest summer league average, 21 games or more. If no previous season winter or summer average, entrant shall use their current highest USBC league average with 12 games or more. Entrants with no USBC certified average must bowl scratch with a 220 average. All averages will be verified. Failure to report highest average will result in disqualification and forfeit of Entry Fee and Prize Money.
6. HANDICAP shall be 85% of 220 and will be computed on a three-game series. Three game series is capped at 900.
7. Prize winnings for previous 12 month must be reported if they are \$600 or more. USBC Rule 319C, & 319D applies to all entrants.
8. Tournament Management shall schedule tournament lanes for each squad of this tournament.
9. PRIZE FEES shall be paid 100% in cash prizes. Entrants shall be eligible for only one prize, that being the highest prize.
10. PRIZE RATIO shall be 1 prize for each five entries.
11. All decisions of the tournament manager / on-site tournament Manager are final unless an appeal is made in accordance with USBC rule 329.
12. Improper conduct during competition shall be cause for disqualification of scores. Failure to comply with above rules shall result in disqualification of scores.
13. Bowlers may enter multiple times but only cash once.
